

# **Fighting The Fake Together**

As we fight the Covid-19 pandemic, we are also dealing with increasing incidents of frauds including counterfeiting, tampering and diversion of life-saving medicines, vaccines & other critical essentials.

With a view to finding a way to combat this counterfeiting menace, ASPA and Messe Frankfurt India brought together key representatives of the industry together in an insightful webinar.

The interactive discussion on "Protecting lives & securing pharmaceutical supply chain during COVID-19" touched upon important aspects in identifying gaps in pharma supply chain and collective steps that can be taken to minimize incidents of tampering.

# **Discussion Overview**

The session was marked by a warm welcome by Messe Frankfurt and ASPA; represented by Mr. Nakul Pasricha, President, ASPA, who also drew attention to research and data-backed insights into the global counterfeiting menace with a focus on Pharma and Covid-19.

#### The panel addressed various aspects of the counterfeiting issue covering topics on:

- The impact of counterfeit drugs on a massively populated country like India public health, profitability, economy at large
- Important measures the GOI undertaking to tackle this menace
- Exigency and challenges in adopting serialization for distribution within India
- Rise of e-pharmacies during the pandemic and the tussle with counterfeiting
- Definitive steps the industry needs to take in prevention of proliferation in supply chain



We in The National Digital Health Mission (NDHM) driven by NHA, are engaging with Centre for Development of Advanced Computing (C-DAC) and coming out with Drug Registry of India which should enable us to track and monitor the pharmaceutical supply chain in a much more efficient way.

Packaging is the key gateway against counterfeiting. A mechanism wherein patients are able to easily digitally authenticate the purchased products on their own works best. I would recommend to go in for a 2 phase implementation: Phase 1 is Digital Authentication. Pharma companies can put Unique IDs on each saleable pack which can be verified for authenticity by patients using digital modes such as Mobile phones, Web, Messaging Apps etc. This should be implemented asap in 2021 itself. Phase 2 will involve complete end-to-end Track & Trace which can be envisaged 2-3 years down the line, say in 2023 or 2024.

CDSCO has taken various actions to disrupt the movement of the spurious drugs in India, including setting up of additional drug testing laboratories at Central and State level, strengthening regulatory measures by increasing manpower, additional equipment for laboratories and special courts set-up in all states to prosecute offenders.

Serialisation has not yet been implemented in India because many pharmaceutical companies still rely on old infrastructure. It calls for complete packaging line automation. We are doing it for exports and should also aim to implement it in our domestic market.




