- He has spent 46 years in the label industry. Entered the label industry in 1978 by starting siliconizing operations. Earlier he worked for family's stationary business started by his father in 1939.
- Those initial days tin catalyst post curing silicone chemistry was in use; he led the change in India by first switching over to solvented platinum catalyst system and then to the solventless coatings which are in use till now.
- Due to non-availability of good quality glassine in India those days he introduced release liners on polycoated and barrier coated papers to his customers using ordinary woodfree papers.
- Started labelstock manufacturing in 1997 and soon became the leading supplier of label materials in India and globally supplying to almost 30 countries.
- He was also the first Indian labelstock manufacturer to install a Nordson hotmelt adhesive coating/laminating line.
- Developed security labels, transfer tapes and double faced labelstock with single liners almost 20 years ago.
- His company was the first Indian labelstock manufacturer ever to exhibit at Labelexpo Europe in Brussels
- In times of recession and intense competition reduced dependence on manufacturing and joined internationally renowned suppliers of label presses, tooling, equipment and consumables as their exclusive agent expanding the range of offerings to his established customer base.

By 2003, started sharing his experiences and knowledge by writing for global magazines and making presentations. His presentation on the market size of labels in India was a part of the Cham Paper Mills pressure sensitive symposium at St. Moritz in Switzerland in 2003.

 He was instrumental in encouraging and supporting entry of Tarsus UK into India and helped in making success of the international label summit in Mumbai.

- In 2006 for his presentation at the Label summit he chronicled the history of label in India starting from the very first pressure sensitive label produced in India
- He was instrumental bringing Tarsus UK and the owners of India Label show together.
 The show was finally acquired by Tarsus and renamed Labelexpo India. Inform Markets eventually acquired tarsus.
- In 2010 in an effort to contribute more from his experiences and knowledge as also expand his deliverance worldwide he started a blog titled "Self-adhesive Labels Industry in India and the world" http://harveersahni.blogspot.com
- · He has been the only Indian ever to have been a member of the Finat committees.
- · He has been the Judge for world label awards multiple times.
- He is on the board of Directors of LMAI (Label Manufacturers Association of India)
- He was the first recipient of the "Lifetime award for support to the India Label Industry" given by LMAI in 2017
- After updating the history of label in India many times thereafter, it is now available on his blog in series of 5 articles.
- He has been curating and helping in organizing networking and knowledge events for LMAI becoming the bridge between the print buyers, Label printers and suppliers.
- His blog is read globally and as of March 2025 it has crossed 6,02,850 pageviews from a very focused global audience consisting of printers, suppliers and brand owners. With 252 articles covering success stories, history, market information and events it is viewed in the following countries; United States, India, Germany, United Kingdom, Canada, France, Brazil, Netherlands, Singapore, Switzerland, Russia, Australia, Spain, South Korea, Kuwait, Qatar, Japan, Pakistan, Sweden and Others. He has also launched a website www.labelsandpackangworld.com complementing his blog. Together both platforms have reached 745,000 page views and are likely to reach a million pageviews this year.
